



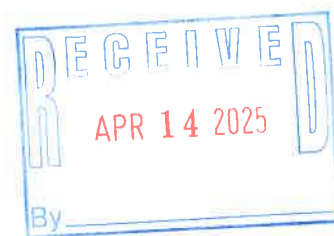

**ADOPTED AMENDMENTS TO THE BY-LAWS OF IMPERIAL  
EMBASSY CONDOMINIUM THREE, INC.**

1. **Adopted amendment to Section 3.1 of the By-Laws of Imperial Embassy Condominium Three, Incorporated (the "By-Laws"), to read as follows:**

3. **DIRECTORS**

3.1 **MEMBERSHIP** The affairs of the Association shall be managed by a Board of ~~seven (7)~~ five (5) members, ~~as determined by the majority vote of the membership,~~ all of whom shall be members of the Association, be up-to-date in the payment of their respective assessments and have complied with the Rules and Regulations of the Association. Changes in Board size may be made by majority vote of the Board from time to time.

2. **Adopted amendment to Section 3.3 of the By-Laws, to read as follows:**

3. **DIRECTORS**

...  
3.3 **TERM AT THE FIRST ANNUAL MEETING** of the Association, ~~the seven members of the Board of Directors shall serve for terms as follows: (Three members shall serve for a term of three years each, two members shall serve for a term of two years each, and two members shall serve for a term of one year each).~~ The term of each director's service shall extend until the next annual meeting of the members and subsequently until his successor is duly elected and qualified or until he is removed in the manner elsewhere provided. At the expiration of the initial term of office of each respective Director, his successor shall be elected for a term of three (3) years.
